If you DO NOT agree to this agreement's terms, do not download, install, and/or use our fonts.

**1. Definitions**

**Fonts Software** – Font Software or Fonts or Typeface is technically a file component software provided by Tegamitype for digital uses (computer, devices, web servers, or application to generate various typographic design assets used by end-users.)

**Tegamitype** – Tegamitype is the leading supplier and original publisher and the Font Software's exclusive owner, and all the related documents such as featured on [www.tegamitype.com](http://www.tegamitype.com).

**Licensee** – The Licensee is an individual, company, and/or other organizations who purchases and uses the Font Software as subjected in this license agreement. Other licensees permitted using the Font Software must belong in the same company, household, and/or listed on the license holder's name as specified on the receipt.

**2. IP Ownership**

**3. Grant of License**

Tegamitype provides a non-exclusive, non-transferable license. This prevents Licensee from assigning or transferring, leasing, selling, sublicensing any rights, duties, or obligations under this agreement, whether in whole or in part, to any third party, including the mergers. Any breach of this will result in the immediate termination of the license agreement. You must delete and destroy all materials or copies (in any medium, digital, and/or physical) containing the breached license.

The licenses being offered by Tegamitype are divided into six types that can be chosen freely according to your needs:

**Standard License:** For use up to 5 individuals/users with an 25k page views per month & 1 domains for website, and 1 Titles & 10k download (each) for apps/epub, & 1 Titles for broadcast.

**Medium License:** For use up to 15 individuals/users with an 50k page views per month & 1 domains for website, and 1 Titles & 50k download (each) for apps/epub, & 1 Titles for broadcast.

**Extra License:** For use up to 30 individuals/ users with an 100k page views per month & 1 domains for website, and 1 Titles & 100k download (each) for apps/epub, & 1 Titles for broadcast.

**Extended License:** For use up to 50 individuals/users with an an 500k page views (each) per month for 2 website domains, and 2 Titles & 500k (each) download for apps/epub, & 2 Titles for broadcast.

**Super License:** For use up to 100 individuals/users with an 1 million page views (each) per month for 2 website domains, and 2 Titles & 1million (each) download for apps/epub, & 2 Titles for broadcast.

**Enterprise License:** For use up to Unlimited individuals/users with an unlimited page views per month & domains for website, and unlimited Titles & app download for apps/epub, unlimited Titles for broadcast.

**4. Proof of Copy**

**5. Authorized Use**

are NOT EDITABLE to third-parties. Licensee(s) may embed and install the Font Software in documents, broadcast programs, and/or other applications for editing, viewing, and printing. There are no download limitations and are bound by a contract with Tegamitype

**5.3 Self-Hosted Website Server Embedding**

Licensee(s) may use the Web Font Format to embed and/or install the leading and sub-domain web using the self-hosting @font-face method. There are no bandwidth restrictions and/or geographical limitations.

**6. Clients & Third Party**

Licensee(s) may grant Tegamitype Font Software to the client, developer, ONLY IF they work specifically for the licensee name (personal/company) specified in the licensee information and purchase receipt. Under the circumstances on which they agree to this license's terms, specifically to ONLY USE the font for the work connected to the Licensee(s). Within thirty (30) days, Tegamitype will try to fix the situation. However, if Tegamitype cannot reach a solution, a refund will be offered to the Licensee. Tegamitype provides no warranty, no refunds, and no responsibility to replace dysfunctioning Font Software resulting from the accident's failure, misuse document of font, and/or negligence of use.

## **11. Updates**

Tegamitype will continuously enhance and develop the typeface collection (adding more styles, expanding language coverage, and fixing bugs) in the future. Licensee(s) will automatically get the updated new version, free of charge, by merely sending us the proof of the older font version purchased.
